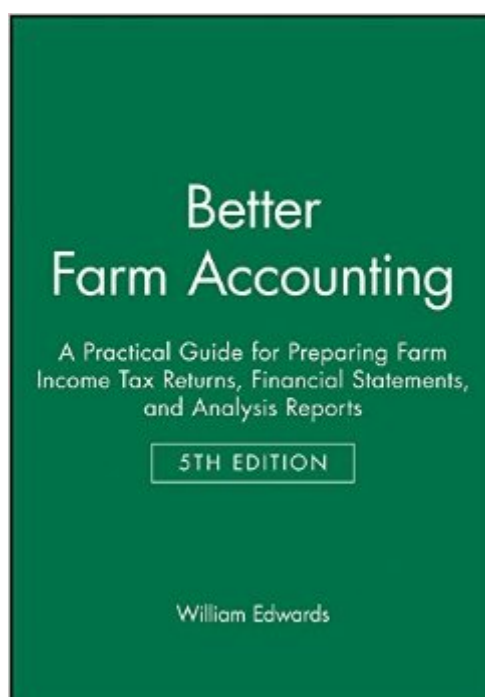

Actually bought this for a farmer friend who has used it for years and was disappointed to find his normal source no longer carried it and was finally able to find it on so had me buy enough for a few years. Only system he has used for many years--loves it.

All this booklet contains is column paper. No guides, lists, etc. All this does is give me a place to hand-write my information. So not necessary in a computerized world. As an accountant, I can't remember the last time I used column paper. If accounting software doesn't have it, I can create it in Excel. This was a waste of money.

This is a book for recording your farm expenses, organized so as to help you with your taxes. Looks very useful, but you would need a new one each year. Not a "how to" book, but a learning

experience. If you work through it, it does answer your questions as to what is tax deductible. I think it would be very useful for anyone with any sort of farm, big or small -- even a market garden. Also for those in the planning stage. Of course, you will never use all the categories (unless you have an extremely diversified large farm), but that's OK.

This booklet is nothing more than a register book. There is not one stitch of instruction in it. The title is deceptive because it looks like a book with tips on farm accounting. Its just a workbook. Waste of money

This book has been extremely helpful in keeping our farm records in order. I would recommend it to anyone in the farming business.

This is a book of forms, assumes you know all about bookkeeping. Not what I expected, but at least it didn't cost much.

Do not get confuse, this document is only about blank records to be used in the farm, and has no further explanations. If you are using Quickbook, all what you need is already within the software package. It may help somebody that is still doing records by hand, but I don't think this happens often now.

My husband is still a pencil/paper farmer! This makes it easy for me to transfer records to the computer!
