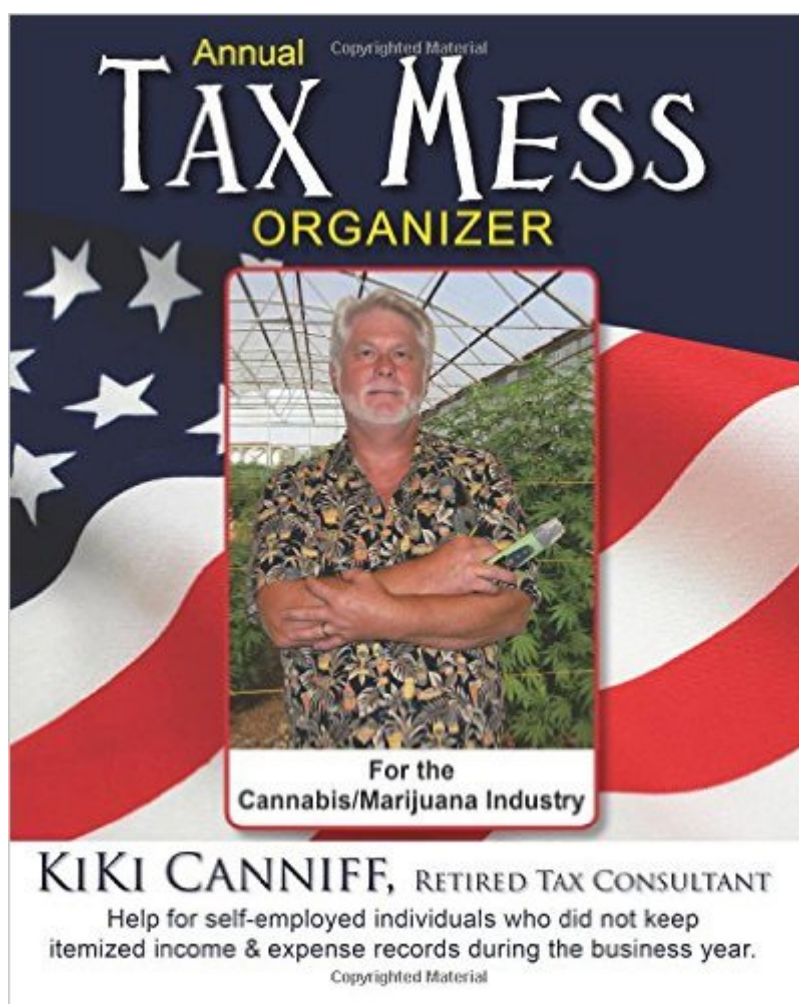

For those who have always prepared their own personal tax return, there is a chapter on how to fill out the small business Schedule C. Self employment taxes, 1040 entries, and other deductions available to the independent contractor are also explained.
